



Micro Irrigation Conversion Rebate

Rebate Offer

Under this program a Palmdale Water District (PWD) customer may receive \$0.25 per linear-foot of micro-irrigation installed, but in no case, will the rebate exceed the amount of \$15,000.00 for a project. Any rebates are subject to state and/or federal tax reporting and IRS guidelines. Recipients will be solely responsible for any taxes or reporting requirements. Rebates are payable to the customer of record in PWD's service area and customer's account must be in good standing.

Duration of program

Funding is limited and will only cover projects initiated and completed within forty-five (45) days of approval.

What project would qualify?

- Minimum conversion requirement is 1000 linear feet of micro-irrigation in the completed project.
- Must have an existing spray irrigation system that's being converted to a micro-irrigation system; new construction does not qualify.

Program Guidelines

- Interested customers should submit a completed program application to PWD (on reverse side).
- Prior to beginning the project, a pre-inspection with a PWD representative is required.
- The project must be completed within forty five (45) days of approval.
- A post-inspection by a PWD representative is required prior to rebate being issued. PWD shall determine the amount of the rebate in PWD's sole discretion.
- By participating in the program, you agree to allow PWD to track your water use and conduct on-site inspections for a five-year period.
- By participating in the program, you agree to authorize PWD to use the project and related information in program-related publicity.

Project Guidelines

- Micro-irrigation system must be on its own zone/station and be connected to a fully operational and programmable controller.
- System must be installed per manufacturer's directions including any recommended filters or pressure regulators.
- Applicant is solely responsible for work of the installation/project, cost of materials and labor, and obtaining any necessary approvals from the City of Palmdale.
