MINUTES OF REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT, MAY 28, 2014:

A regular meeting of the Board of Directors of the Palmdale Water District was held Wednesday, May 28, 2014, at 2029 East Avenue Q, Palmdale, California, in the Board Room of the District office. President, Kathy Mac Laren, called the meeting to order.

1) Pledge of Allegiance.

At the request of President Mac Laren, Director Dino led the pledge of allegiance followed by a moment of silence for our military.

3) Adoption of Agenda.

It was moved by Director Alvarado, seconded by Director Estes, and unanimously carried to adopt the agenda, as written.

Water Conservation Aide Trevino informed the Board of the five recent Cash for Grass recipients and then introduced Cash for Grass recipient, Mr. Don Holloman. Mr. Holloman and his family then provided an overview of their participation in the District's Cash for Grass Program, thanked the Board for developing this Program, and then offered suggestions for improvements to the Program.

Assistant General Manager Knudson provided a brief overview of Resolution No. 14-10 and the Antelope Valley Integrated Regional Water Management Plan process after which it was moved by Director Estes, seconded by Director Alvarado, and unanimously carried by all members of the Board of Directors present at the meeting

to approve the adoption of Resolution No. 14-10 being a Resolution of the Governing Board of the Palmdale Water District Approving the Adoption of the 2013 Update to the Antelope Valley Integrated Regional Water Management Plan.

A copy of said Resolution No. 14-10 is hereby made a portion of the minutes of this meeting.

7.2) Consideration and Possible Action on District Membership in the Antelope Valley Hispanic Chamber of Commerce. (\$350.00 – Non-budgeted – General Manager LaMoreaux/Outreach Committee)

General Manager LaMoreaux reviewed the Outreach Committee's recommendation to become a member of the Antelope Valley Hispanic Chamber of Commerce, as well as a member of the African-American Chamber of Commerce, after which Mr. Isaac Barcelona, co-founder and President of the Antelope Valley Hispanic Chamber of Commerce, provided an overview of the benefit of membership in their Chamber.

It was then moved by Director Dino, seconded by Director Estes, and unanimously carried by all members of the Board of Directors present at the meeting to approve District membership in the Antelope Valley Hispanic Chamber of Commerce in the not-to-exceed amount of \$350.00.

8) Information Items.

8.1) Reports of Directors: Meetings/Committee Meetings/General Report.

Director Estes reported that on May 20, he and Director Dino attended the Facilities Committee meeting where there was discussion regarding a long-term GAC contract with Calgon Carbon and new Chromium VI regulations, additional quotes were requested for a new digital wireless voting system for the Board room, the Committee toured the Leslie O. Carter Water Treatment Plant, and Plant staff is to be congratulated for their work on winter maintenance; that on May 21, he and Director Dizmang attended the Outreach Committee meeting where there was discussion regarding District membership in the Chambers of Commerce considered earlier this evening, the District's website redesign, and manning a booth at the Four-Points Swap Meet; that the Personnel Committee meeting scheduled for May 22 was cancelled; and that on May 27, he and Director Alvarado attended a Board briefing with General Manager LaMoreaux.

Director Alvarado reported that on May 20, he attended the Facilities Committee meeting and tour of the Leslie O. Carter Water Treatment Plant, he is very impressed with the sophistication of the District's treatment of water, and then expressed kudos to Plant staff; that on May 21, he attended the Outreach Committee meeting; that also on May 21, he attended the Palmdale Recycled Water Authority meeting; that on May 22, he attended the District's Cash for Grass Workshop and expressed kudos to Water Conservation Aide Trevino for her work hosting the Workshop; that on May 27, he and Director Estes attended a Board briefing with General Manager LaMoreaux; that on May 29, he will be attending the Antelope Valley State Water Contractors Association meeting; and that on May 31, he will be attending the District's Employee Appreciation Day. A copy of

Director Alvarado's detailed written report is hereby made a portion of the minutes of this meeting.

President Mac Laren reported that on May 21, she attended the Palmdale Recycled Water Authority meeting where the Authority's business was conducted, City Councilman Fred Thompson was welcomed to the Authority, and the Authority Board discussed Los Angeles County Waterworks issues; that on May 22, she met with Dr. Mathis and General Manager LaMoreaux to ensure everyone is moving in the right direction; and that Strategic Initiatives have been posted, and she looks forward to the completion of the Strategic Plan brochure.

Director Dino reported that on May 19, he attended the Water Supply & Reliability Committee meeting where they discussed the Littlerock Dam Sediment Removal Project and the Littlerock Creek Recharge and Recovery Project; that on May 20, he attended the Facilities Committee meeting with Director Estes; that on May 21, he attended the Palmdale Recycled Water Authority meeting as the Alternate Member, and progress is slow but is moving along; and that on May 27, he attended a Board briefing with General Manager LaMoreaux.

There were no further reports from Directors.

8.2) Report of General Manager.

a) Palmdale Recycled Water Authority Status.

General Manager LaMoreaux reported that Site Supervisor Training for Palmdale Recycled Water Authority Board Members, Alternate Members, and the general public will be held June 5, 2014 at 10:00 a.m. at the City of Palmdale and that the next regular meeting of the Authority is scheduled for June 18, 2014 at the City of Palmdale.

He then stated that iPad training for the Directors is scheduled for 8:00 a.m. on June 5, 2014.

b) Monthly Department Reports.

He then reported that the Monthly Department Status Report was included in the agenda packets if there are any questions on same and that an additional report regarding water conservation activities since January was placed before the Board this evening.

c) District Vacancy Report.

He then reported that for the District's three open positions, the PIO/Water Conservation Director position is currently under recruitment by The Mathis Group, and staff is working on recruitment of two Service Worker positions.

He then reported that over 160 guests have confirmed attendance at this weekend's picnic and that the District's insurance carrier has restricted the use of alcohol at the event followed by discussion of this restriction.

8.3) Report of Attorney.

Attorney Wynder provided an overview of the California Water Bond Bills included in their written report, and after discussion of the proposed Bills, he recommended the District either endorse, oppose, or remain neutral on the proposed Bills.

RESOLUTION NO. 14-10

RESOLUTION OF THE GOVERNING BOARD OF THE PALMDALE WATER DISTRICT APPROVING THE ADOPTION OF THE 2013 UPDATE TO THE ANTELOPE VALLEY INTEGRATED REGIONAL WATER MANAGEMENT PLAN

WHEREAS, the State of California Department of Water Resources (DWR) created the Integrated Regional Water Management (IRWM) Program to encourage integrated, regional strategies for managing water resources and to provide funding for both planning and implementation of projects that support management of water supply, water quality, environmental interests, drought protection, flood protection, and reduction of dependence on imported water and many other; and

WHEREAS, the Antelope Valley-East Kern Water Agency; Palmdale Water District; Quartz Hill Water District; Littlerock Creek Irrigation District; Antelope Valley State Water Contractors Association; City of Palmdale; City of Lancaster; County Sanitation District No. 14 of Los Angeles County; County Sanitation District No. 20 of Los Angeles County; Rosamond Community Services District; and Los Angeles County Waterworks District No. 40, Antelope Valley, have established a Regional Water Management Group (RWMG) by means of a Memorandum of Understanding; and

WHEREAS, DWR and State Legislators have established program guidelines for the IRWM Program though Proposition 84 and Proposition 1E (2012 Guidelines); and

WHEREAS, the RWMG for the Antelope Valley IRWM Region is responsible for the preparation and adoption of an IRWM Plan; and

WHEREAS, the RWMG for the Antelope Valley IRWM Region has developed the 2013 Update to the Antelope Valley IRWM Plan to address the provisions of the 2012 Guidelines; and

WHEREAS, the RWMG solicited and incorporated input from all interested stakeholders in preparation of the 2013 Update to the Antelope Valley IRWM Plan; and

WHEREAS, the adoption of the 2013 Update to the Antelope Valley IRWM Plan will enable participants in the Antelope Valley IRWM to apply for future grant funding under various grant programs including grants from Proposition 84 and Proposition 1E; and

WHEREAS, the adoption of the 2013 Update to the Antelope Valley IRWM Plan is exempt from the California Environmental Quality Act under section 15262 of the guidelines as a project involving only feasibility or planning studies for possible future actions; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Palmdale Water District does hereby:

1. Adopt the 2013 Update to the Antelope Valley Integrated Regional Water Management Plan.
