3) Adoption of Agenda.

It was moved by Director Dizmang, seconded by Director Dino, and unanimously carried to adopt the agenda, as written.

4) Workshop to Review Palmdale Water District's Organization Chart. (General Manager LaMoreaux/Dr. Bill Mathis, The Mathis Group)

Dr. Bill Mathis, of The Mathis Group, introduced the top two candidates for the PIO/Conservation Director position followed by staff's review of the proposed Organization Chart and a detailed discussion of the Board's proposed changes to the Organization Chart, each Board member's specific concerns regarding certain positions and departments, and receiving agenda item materials prior to meetings.

Director Estes then moved to revise the proposed Organization Chart moving the Assistant General Manager position under the Water & Energy Resources Director position with all other positions reporting to the Assistant General Manager, separating the Customer Service and Finance Departments into two departments with the Finance Manager position over Finance and the Customer Service Supervisor position over Customer Service, and moving all Field Customer Service Tech. positions under Facilities.

After a further detailed discussion of these proposed revisions, of staff's recommendations to approve the Organization Chart as presented, of retitling certain positions to better reflect their duties, of defining the Board's specific Customer Service Department concerns and expectations for this Department, of the proposed intern positions, and of developing a Customer Service Improvement Plan, Director Estes rescinded his motion.

It was then moved by Director Dizmang, seconded by Director Dino, and unanimously carried to approve the Organization Chart, as presented, with the exception of changing the title of Field Service Technicians to Field Customer Service Representatives and that the Board conduct a six-month evaluation of the General Manager in the first part of August, which will include a progress report on the evaluation of the Customer Service Department.

It was then determined that the proposal received from The Mathis Group for recruitment of the Engineering/Grant Writer Manager position be placed on the next agenda for consideration.
