DIRECTOR CANDIDATE BIOGRAPHIES CLASS OF 2017

JIM ALLEN - QI-SOLUTIONS - Jim Allen is the Sr. Program/Site Manager for QI-Solutions® at AFRL and also an Adjunct Instructor with ITT in Sylmar. Following his Air Force and Air National Guard career Jim's love of aerospace brought him to the Antelope Valley in 1985 as a member of the B-1B team, transitioned to the B-2A with Northrop Grumman in 1991, coached gymnastics at AV Twisters from 1989-1999 and moved to the Jet Propulsion Laboratory in 2001. Jim has earned a Bachelors and Masters of Science degrees from Azusa Pacific University, and is starting a Global MBA in the fall. He is a member of the AVBOT Aerospace committee, assisted on the BOC committee, recently a volunteer for the LA County Airshow, and is the President of High Desert Saltwater Anglers. Jim enjoys traveling with his wife, snowboards with his daughter, skis, goes saltwater and fly fishing, visits his grandson's family in Lake Almanor and maintains marine aquariums.

BRET BANKS – ANTELOPE VALLEY AIR QUALITY MANAGEMENT DISTRICT (AVAQMD) - Bret Banks is the Operations Manager for the Antelope Valley Air Quality Management District. As Operations Manager, Bret has the primary responsibility for overseeing the District's day-to-day operations, including its permit, compliance, and regulatory development programs. Bret has been member of the Antelope Valley Board of Trade since 2000.
