TERMS AND CONDITIONS

ELIGIBILITY:

- 1) All participants must be a Palmdale Water District customer and the property owner of the rebate installation site.
- 2) Program is based on first come first serve basis/ with availability of funds
- 3) PWD single family, multi family or commercial customer (single family takes precedence over commercial)
- 4) There will be no time delay for multiple rebates per person.
- 5) Rebates will stop when funds are depleted.
- 6) The District reserves the right to contact the customer and check for installation of all rebates.
- 7). The applicant must have an account in good standing with the District and the site must have a minimum of approximately one year of water consumption history so that a pre and postwater consumption comparison can be conducted.

CONDITIONS:

- 1) The applicant must purchase a "Smart Water Application Technology" (SWAT) tested irrigation controller.
- 2) The applicant must install and program the SWAT tested irrigation controller for maximum water savings either by a licensed contractor or himself.
- 3) The participant agrees to leave the "ET/ Smart" irrigation controller in place for a minimum of five years provided that ownership of the property does not change.
- 5) The participant agrees to allow the Palmdale Water District to inspect the property at any time within the first year of the program for the installation of the controller.
- 7) The participant agrees to allow the District to contact him or her for the purpose of conducting program research and agrees to participate in the customer satisfaction poll
- 8.) The participant has read and agrees to the conditions set forth in the following disclaimer:
