# 4.1) Consideration and Possible Action on Approval of Minutes of Meeting Held January 11, 2011.

# 4.2) Presentation of Monthly Water Demand and Supply Status. (Water & Energy Resources Manager Pernula)

4.3) Presentation of Overview of District's Water Production, Storage Options, Resource Management, and Financial Planning to Ensure Adequate Water Supplies. (Water & Energy Resources Manager Pernula)

Water & Energy Resources Manager Pernula provided an overview of the District's 2011 water supply picture including Department of Water Resources reservoir levels, multi-year storage comparisons in Lake Oroville, relevant data used to calculate the District's water supply analysis, production and customer water use for 2011, a comparison of 2010 and 2011 water treatment plant and ground water production calculations and customer consumption, projected water demands for 2011, projected and actual water production based on a 60% State Water Project allocation, firm water supplies for 2011, and 2011 estimated demands and the supply to be used to meet this demand.

### 5) Project Updates.

5.1) Recycled Water Master Plan. (Water & Energy Resources Manager Pernula)

Water & Energy Resources Manager Pernula stated that there is no progress on this Plan due to legal issues.

5.2) Strategic Water Resources Plan. (Water & Energy Resources Manager Pernula)

Water & Energy Resources Manager Pernula stated that work continues on the environmental documents for this Plan with requested information being provided to ESA.

5.3) Water Purchase Opportunities. (Water & Energy Resources Manager Pernula)

Water & Energy Resources Manager Pernula stated that staff is negotiating an exchange with another State Water Contractor to pay back a water debt to West Kern.

5.4) Garden Bar Water Supply and Power Project. (Water & Energy Resources Manager Pernula)

Water & Energy Resources Manager Pernula stated that the Committee has been provided with a draft Reconnaissance-Level Investigation Report for the Garden Bar Reservoir Project for review; that a meeting is scheduled with the project partners this Thursday at South Sutter to review the Report; and that RMC would like to discuss this project with the Water Supply & Reliability Committee.
