

SPECIALIST FROM PART-TIME TO FULL-TIME.

Recommendation:

Staff recommends that the Palmdale Water District embrace and approve the hiring of Laura Gallegos into a full-time Public Affairs Specialist position. She currently serves a part-time role but as our company brand continues to grow, our image and partnerships will continue to need assistance in managing and creation.

Outreach to the community is an essential function of this organization, and because of the diversity of our rate payers, the continued need for water education, and the immense development of materials needed to effectively message PWD information to the community, a full-time Public Affairs Specialist is necessary for continued success in this area.

Alternative Options:

Not supporting this initiative and staying with the status quo which is counterproductive to the current positive momentum that PWD enjoys.

Impact of Taking No Action:

Not adhering to our Strategic Plan initiatives of regional leadership and innovation. Continuing to be mundane, ordinary, and commonplace while not supporting our mission statement and the vision of the District by engaging our rate payers through education, outreach, and the development of materials that are specifically focused to, written to a specific educational scale, and distributed in both traditional and non-traditional platforms to ensure a blanketed effort to reach our community.

Recommendation:

Staff recommends that the Board consider extending the Internship Program for an additional semester.

Alternative Options:

The alternative is to allow our internship program to expire.

Background:

The District has had eight student interns. Two have found employment at other Districts after their internship with PWD. One has been accepted into an elite program at UCSF in their Chemistry Department. Two have filled positions here at the Palmdale Water District and another is on this agenda to move from an internship to an Engineering Technician position. We would like to continue the student internship program for 2017 with spring internships in the area of Human Resources, Laboratory Analyst, Operations Technician and Service Worker. We will also be pursuing return to work interns for our Customer Care Department.

Strategic Plan Initiative:

This work is part of Strategic Initiative No. 2 - Organizational Excellence.

Budget:

The cost of this will be incorporated into our 2017 budget proposal. Our first semester internship will begin at \$11.50/hr. for 20 hours per week.
