#### **Recommendation:**

Proposed Resolution PRWA No. 2016would not change the regular meeting date or time, but would set the regular meeting location to the City of Palmdale City Council Chambers for future meetings.

## RESOLUTION OF THE PALMDALE RECYCLED WATER AUTHORITY REPEALING RESOLUTION NO. PRWA 2013-004 AND SETTING FORTH THE PRWA'S REGULAR MEETING DATE, TIME AND LOCATION

WHEREAS, Section 4.5 of the "Joint Exercise of Powers Agreement Creating the Palmdale Recycled Water Authority" (hereinafter JPA), authorized the Board of the Palmdale Recycled Water Authority, hereinafter the "Board" to adopt a resolution that sets forth the regular meeting dates, times and locations, and

WHEREAS, at its meeting held on February 13, 2013, the Board adopted Resolution No. PRWA 2013-004 setting forth its regular meeting date, time and a location that alternated between the City of Palmdale City Council Chambers and the Palmdale Water District Board Room, and

WHEREAS, a recent re-allocation of duties and responsibilities of the JPA members with regard to finances and billing resulted in an imbalance in the respective workloads with more work being allocated to the Palmdale Water District. To correct this imbalance staff was directed to have the duties of the Authority Secretary, such as, meeting organization, agendas, record keeping, filing officer and the like, allocated solely to the City Clerk for the City of Palmdale and to hold future meetings of the PRWA in the Palmdale City Council Chambers.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Palmdale Recycled Water Authority:

Section 1. That Resolution No. PRWA 2013-004 is hereby repealed in its entirety.

Section 2. That the regular meetings of the Board of the Palmdale recycled Water Authority be held on the third Wednesday of each month at 7:00 PM.

Section 3. That the regular meeting location of the Board of the Palmdale Recycled Water Authority be held in the Palmdale City Council Chambers located at 38300 Sierra Highway, Suite "B", Palmdale California.

**RE:** AGENDA ITEM NO. 7.1 – REPORT REGARDING DISCUSSION AND POSSIBLE ACTION ON PROVIDING COMPENSATION AND/OR TRAINING REIMBURSEMENT FOR THE FIFTH DIRECTOR

#### **Recommendation:**

Palmdale Recycled Water Authority (PRWA) staff recommends that the Board consider the issues below and provide further direction.

#### **Background:**

At the PRWA Board meeting on January 20, the Board discussed a proposal to provide compensation for the Fifth Director. The Fifth Director is appointed jointly by the City of Palmdale and the Palmdale Water District, and currently receives no compensation or reimbursement for training (which includes conferences and travel). The consensus of the Board was to request staff to bring back options for the Board to consider. Since that time, the City's City Council has considered the issue and given direction on the City's position. Thus, this staff report presents options within those parameters.

Section 4.11 of the Joint Powers Agreement provides for Director Compensation. Compensation for City members is borne by the City, and compensation for District members is borne by the District. The Board may adopt a policy relating to the reimbursement of expenses incurred by the Directors. Finally, "Members may provide for compensation and/or reimbursement of expenses to the fifth director, as allowed by law."

The direction from the City was for PRWA staff to present a budget to the PRWA Board that includes specific account(s) for training and compensation for the Fifth Director. Any funds are to be paid solely from PRWA revenues and not from City or District revenues. That budget is presented as a separate agenda item.

Legal counsel from the City and the District have agreed that if the Directors wish to proceed with compensation and/or reimbursement for the Fifth Director, this could be accomplished by the City

and the District each adopting resolutions authorizing the PRWA to allocate and pay such funds. An amendment to the Joint Powers Agreement is not necessary.

## **Financial Impact:**

The Fiscal Impact is described in the proposed Budget.

#### **Recommendation:**

Palmdale Recycled Water Authority (PRWA) staff recommends approving the proposed 2016 budget as presented in the 2016 Budget Document and approval of Resolution No. PRWA 2016-005 authorizing the adoption of the Palmdale Recycled Water Authority 2016 Budget.

#### Background:

A part of the Palmdale Recycled Water Authority's duties is to create an annual operating budget. The proposed 2016 Budget highlights revenue from water sales, member contributions, and anticipated projects. The budget also outlines expenditures such as consultant services, training, and recycled water purchases.

As outlined in the Joint Powers Agreement Section 14.11, a line item has been added to the budget for the ability to compensate the 5<sup>th</sup> board member of the Authority for attendance at regular meetings. This line item will be funded from revenues of recycled water sales.

#### Financial Impact:

As set forth in the 2016 Budget Document, the fiscal year is projected to result in \$397,260 in unappropriated reserves. Member agency contributions and the projected water sales constitute the 2016 revenue of \$244,500. The projected expenses are \$273,500 which includes \$200,000 in contracted professional services. Approximately \$165,000 of the contracted professional services are encumbrances from 2015.

### A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PALMDALE RECYCLED WATER AUTHORITY AUTHORIZING THE ADOPTION OF THE PALMDALE RECYCLED WATER AUTHORITY 2016 BUDGET

WHEREAS, The Palmdale Recycled Water Authority has identified the need for a 2016 Budget, and

WHEREAS, The Palmdale Recycled Water Authority Board reviewed the proposed Budget for fiscal year 2016, and

WHEREAS, the Palmdale Recycled Water Authority considered the proposed budget as submitted and made all changes and amendments thereto which said Authority, desired to make therein; and

WHEREAS, individual project costs have been proportionately budgeted to the respective project areas based upon the benefit attributable to the targeted project area including improving inadequate public improvements and public facilities, improving and correcting depreciated values; and,

WHEREAS, the Palmdale Recycled Water Authority has approved a fund reserve for emergency situations such as natural disasters; and,

WHEREAS, the Palmdale Recycled Water Authority has heretofore, or hereafter will, raise sufficient revenues to finance and balance said budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Palmdale Recycled Water Authority:

SECTION 1: The original of the Budget of the Palmdale Recycled Water Authority shall be placed on file in the office of the Authority Clerk and shall be open to public inspection.

SECTION 2: The Palmdale Recycled Water Authority hereby approves all of the adjustments to the fiscal year 2016 revenues and expenditures as presented in the fiscal year 2016 budget document.

SECTION 3: The Budget of the Palmdale Recycled Water Authority is hereby approved and adopted. In adopting said budget the Authority Board approved the specified amounts for each of the various programs and accounts set forth.

SECTION 4: The Authority Treasurer is hereby authorized and instructed to take all steps necessary to implement this resolution in accordance with the provisions of the budget document.

SECTION 5: Without prior approval of the Authority Board, the Executive Director shall have authority to transfer up to \$25,000 from program to program, except for shifts in appropriations relating to personnel. Any transfer of more than such amount shall be approved by the Authority Board.

SECTION 6: The Authority Treasurer, with the approval of the Executive Director shall approve the Encumbrances and Continuing Appropriations from the Authority's budget for fiscal year 2016.

SECTION 7: The Budget for fiscal year 2016, as submitted, amended, modified. revised, corrected, adopted, and filed by the Authority shall be the fiscal year 2016 Budget for the Palmdale Recycled Water Authority. The Budget is subject to the requirements of Article XIII B of the California Constitution.

SECTION 8: The Clerk of the Authority shall certify to the adoption of this Resolution and enter it into the official records of the Authority.
