Director Dino, AVEK Liaison, reported that on February 9, he attended an AVEK Board meeting where they appointed George Lane to fill their vacant Director position, voted to transfer banked water, and considered the Department of Water Resources' Long Term Water Supply Agreement.

2) Antelope Valley State Water Contractors Association. (Director Mac Laren-Gomez/Director Dizmang/Director Merino, Alternate)

Director Mac Laren-Gomez, Antelope Valley State Water Contractors Association (AVSWCA) Commissioner, reported that on February 11, she attended an AVSWCA meeting where they elected officers, discussed having the Antelope Valley Watermaster handle the USGS Well Monitoring Program, and reviewed the Big Rock Creek Joint Ground Water Recharge Project.

3) Personnel Committee Meeting. (Director Mac Laren-Gomez, Chair/Director Merino)

Director Mac Laren-Gomez, Personnel Committee Chair, reported that on February 17, she attended the Personnel Committee meeting where they considered the District's COVID-19 Prevention Program approved earlier this evening and will be reviewing job classifications prior to the upcoming salary survey and Director pay and benefits using same the agency comparisons as the salary survey.

4) Palmdale Recycled Water Authority. (Director Dino/Director Wilson/Director Mac Laren-Gomez, Alternate)

Director Dino, Palmdale Recycled Water Authority (PRWA) Director, reported that on February 17, he attended the PRWA meeting where they recommended Zakeya Anson as PRWA's fifth member of the Board of Directors.

Director Wilson, Palmdale Recycled Water Authority (PRWA) Director, reported that officers were also elected with Director Dino elected as Chair.

General Manager LaMoreaux then clarified that the Palmdale City Council and the Palmdale Water District Board of Directors must vote on the PRWA Directors' recommendation of Ms. Anson as the fifth member of the PRWA Board of Directors and that Juan Carrillo was elected Vice Chair.

She then stated that during the course of the City of Palmdale's Community Clean-Up Event near Barrel Springs Road, she requested General Manager LaMoreaux attend as a cistern was discovered; that gates will be installed in this area to help prevent illegal dumping; and that assistance from all agencies is needed to remove debris and equipment abandoned in this area after which a member of the clean-up crew emphasized the need for heavy equipment assistance to clean up the area.

Director Merino reported that on February 4, she attended a Board briefing; that on February 8, she attended the Palmdale Water District Regular Board Meeting; that on February 9, she listened to the AVEK Board meeting; that on February 10, she attended a briefing; that on February 11, she attended a briefing; that also on February 11, she listened to the Antelope Valley State Water Contractors Association meeting; that on February 17, she attended the Personnel Committee meeting; that on February 18, she attended a Board briefing; and that on February 24, she will be attending the AV EDGE Virtual Business Outlook Conference.

President Dizmang reported that on February 10, she attended a briefing for the Antelope Valley State Water Contractors Association; that on February 11, she attended an Agenda Review and Approval briefing; that also on February 11, she attended the Antelope Valley State Water Contractors Association meeting; that on February 17, she listened to the Palmdale Recycled Water Authority meeting; that also on February 17, she attended an Agenda Review and Approval briefing; that on February 18, she attended a Board briefing; that on February 22, she is attending the Palmdale Water District Regular Board Meeting; that on February 23, she will be attending an interview with the Café Con Leche radio program; and that on February 24, she will be attending the AV EDGE Virtual Business Outlook Conference.

8.2) Report of General Manager.

a) February 2021 Written Report of Activities Through January 2021.

General Manager LaMoreaux stated that he submitted a written report with the agenda packets if there are any questions and then highlighted below normal precipitation and the effect on reservoir levels.

He then provided a detailed report on the Barrel Springs cistern located during the City of Palmdale's Community Clean-Up Event last weekend and stated that the City of Palmdale's Code Enforcement Officer will notify the property owner of the need to abandon the cistern or provide a solid lid; that staff is working with City of Palmdale staff to determine a location to install gates to help prevent further dumping and will meet with City of Palmdale staff later this week to investigate the cistern and the general area; that the District's property in this area is west of the equestrian parking area; and that there is very little dumping on the District's property followed by discussion of providing mutual aide assistance with the District's equipment and the City of Palmdale charging the property owner for clean-up to prevent the District's ratepayers from incurring this cost.

He then stated that the first meeting of the Board of Directors for the Delta Conveyance Design and Construction Authority was held last week; that they discussed providing assistance and the schedules for obtaining California Environmental Quality Act (CEQA) compliance and the Notice of Determination; and that a National Environmental Policy Act (NEPA) document will be performed by a federal agency parallel with the time frame for obtaining permits followed by discussion of the timeframe for completion of the single tunnel.
