A regular meeting of the Board of Directors of the Palmdale Water District was held Wednesday, April 12, 2017, at 2029 East Avenue Q, Palmdale, California, in the Board Room of the District office. President, Robert Alvarado, called the meeting to order at 7:01 p.m.

3) Adoption of Agenda.

It was moved by Director Dino to adopt the agenda, as written.

It was then moved by Director Dino, seconded by Director Mac Laren, and unanimously carried by all members of the Board of Directors present at the meeting to adopt the agenda, as amended, to consider Agenda Item No.'s 9, 10, 11, and 12 after Agenda Item No. 4.

Ms. Waunette Cullors, coordinator for the Miss Latina Antelope Valley Pageant, provided an overview of their organization after which the Board presented Certificates

of Appreciation to the queens and contestants for the Miss Latina Antelope Valley and Miss Black Antelope Valley pageants.

5.1) Oroville Dam and Flood Management. (Deputy Water & Energy Resources Director Thompson II)

Deputy Water & Energy Resources Director Thompson II provided an overview of the purpose of Oroville Dam & Reservoir, recent flood damage to the spillway structure at Oroville Dam, Department of Water Resources' efforts to repair the damage, and the impact to water supplies followed by discussion of State Water Project allocations, cost of repairs to the spillway structure, and the impact to the State Water Contractors.

President Alvarado announced the items included in the Consent Calendar after which it was moved by Director Henriquez, seconded by Director Estes, and unanimously carried by all members of the Board of Directors present at the meeting to approve those items included in the Consent Calendar.

- 7.1) Consideration and Possible Action on Defunding the Vacant Senior Service Worker Position and Funding the Engineering Technician I Position. (Human Resources Director Emery/Personnel Committee)

Human Resources Director Emery provided an overview of the Senior Service Worker and Engineering Technician I positions, and after a brief discussion of the salary range, succession planning, savings to the District, and the Personnel Committee's recommendation to approve this item, it was moved by Director Henriquez, seconded

by Director Estes, and unanimously carried by all members of the Board of Directors present at the meeting to defund the vacant Senior Service Worker position and fund the Engineering Technician I position.

7.2) Consideration and Possible Action on Resolution No. 17-13 Being a Resolution of the Board of Directors of the Palmdale Water District in Support of the Association of California Water Agencies' Policy Statement on Bay-Delta Flow Requirements. (Deputy Water & Energy Resources Director Thompson II)

Deputy Water & Energy Resources Director Thompson II provided an overview of Resolution No 17-13, and after a brief discussion of Delta flow and ACWA's position, it was moved by Director Mac Laren, seconded by Director Henriquez, and unanimously carried by all members of the Board of Directors present at the meeting to approve Resolution No. 17-13 being a Resolution of the Board of Directors of the Palmdale Water District in Support of the Association of California Water Agencies' Policy Statement on Bay-Delta Flow Requirements.

A copy of Resolution No. 17-13 is hereby made a portion of the minutes of this meeting.

7.3) Consideration and Possible Action on Resolution No. 17-14 Being a Resolution of the Board of Directors of the Palmdale Water District Requiring that Board Members be Elected by Division Starting in November of 2018. (President Alvarado/Director Mac Laren)

General Counsel Dunn provided an overview of Resolution No. 17-14, and after a brief discussion of the Resolution and of potential lawsuits, it was moved by Director Henriquez and seconded by Director Mac Laren to approve Resolution No. 17-14 being a Resolution of the Board of Directors of the Palmdale Water District Requiring that Board Members be Elected by Division Starting in November of 2018.

Ms. Joanne Granai, Palmdale resident, stated that she looks forward to this method of election to bring better representation to her division.

The motion was then unanimously carried by all members of the Board of Directors present at the meeting.

Director Henriquez requested "Presentation on P3 partnerships" be included on a future agenda.

He then requested that Assemblyman Lackey and Congressman Knight also be included in the District's facilities tour with Senator Wilk as he emphasized to Senator Wilk the importance of funding and grants for the District after which General Manager LaMoreaux stated that this tour will be scheduled, and staff will provide them an overview of ongoing water issues in the Antelope Valley in addition to updates on the District's recycled water projects.

Director Mac Laren requested "Presentation on current and future costs associated with State Water Project operations" be included on a future agenda.

President Alvarado requested "Presentation of Certificates of Appreciation to Palmdale School District employees for outstanding performance in a classroom" be included on a future agenda.

Director Henriquez then requested the District's employees be recognized on a continuous basis to ensure employees know they are appreciated for the job they do, and General Manager LaMoreaux reviewed the District's PACE employee recognition program.

RESOLUTION NO. 17-13 A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT IN SUPPORT OF THE ASSOCIATION OF CALIFORNIA WATER AGENCIES' POLICY STATEMENT ON BAY-DELTA FLOW REQUIREMENTS

WHEREAS, California is facing a defining moment in water policy that will be substantially impacted by the State Water Resources Control Board's approach to water quality objectives under the Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta; and

WHEREAS, the State Water Board has the responsibility for updating the Bay-Delta Plan in a manner that establishes water quality objectives that ensure the reasonable protection of all beneficial uses of water in a way that is consistent with the coequals goals of improving water supply reliability and protecting, restoring and enhancing the Delta ecosystem and with respect to the commitments made in the California Water Action Plan; and

WHEREAS, the State Water Board staff's current proposal, which focuses singularly on an "unimpaired flow" approach, is irreconcilable with a policy of coequal goals of improving both water supply reliability and ecosystem health; it is also inconsistent with the broader water policy objectives of the Brown Administration; and

WHEREAS, the ACWA Board of Directors has unanimously adopted a strong policy statement calling for a better approach that can more effectively achieve ecological objectives while maintaining water supply reliability. The statement calls on the State Water Board to set aside its "unimpaired flow" approach and heed Gov. Jerry Brown's call for negotiated agreements, which have been successful on many rivers and tributaries in California; and

WHEREAS, the ACWA statement notes that to be successful, the state's flow policy must be consistent with the principles of collaboration, comprehensive solutions, science, functional flows, economic considerations, consistency with state policy, and leadership; and

WHEREAS, California's local urban and agricultural water managers are united in their vision for a future that includes a vibrant California economy, as well as healthy ecosystems and fish populations, and believe that vision is best achieved through comprehensive, collaborative approaches;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Palmdale Water District herby supports ACWA's Policy Statement on Bay-Delta Flows and encourages the State Water Resources Control Board to embrace the approach articulated in ACWA's policy statement.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT REQUIRING THAT BOARD MEMBERS BE ELECTED BY DIVISION STARTING IN NOVEMBER OF 2018

- WHEREAS, the Palmdale Water District is an irrigation district and is a state agency formed and existing for government purposes pursuant to Water Code section 20500 et. seq; and
- WHEREAS, pursuant to Resolution No. 16-19 and by Los Angeles County Board of Supervisors action taken April 4, 2017, the Board of Directors of the Palmdale Water District holds its general elections on the first Tuesday after the first Monday in November of each even-numbered year; and
- WHEREAS, Palmdale Water District Board of Directors are currently elected from division and voted for at large; and
- WHEREAS, in furtherance of the purposes of the California Voting Rights Act of 2001, the Palmdale Water District Board of Directors desires to change, by this Resolution, the method of election for members of its governing board from an at-large, from-division method of election to a by-division method of election; and
- WHEREAS, pursuant to Elections Code Section 10650(a), effective January 1, 2017, the Board of Directors may by resolution change to a by-division method of election without submitting this Resolution to the voters for approval.
- **NOW, THEREFORE, BE IT RESOLVED,** by the Board of Directors of the Palmdale Water District as follows:
- **Section 1.** The above recitals are all true and correct and are hereby incorporated herein by reference and adopted as findings.
- **Section 2.** The method of election for members of the governing board of the Palmdale Water District shall be by division starting with the election in November of 2018.
- **Section 3.** The Board President, General Manager, and General Counsel are hereby authorized and directed to execute and submit documents to the Los Angeles County Board of Supervisors and Registrar of Voters as necessary to carry out this Resolution.
- **Section 4:** If any section, subsection, paragraph, sentence, clause or phrase of this resolution is for any reason held to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity or constitutionality of the remaining portions of this resolution, it being expressly declared that this resolution and each section, subsection, paragraph, sentence, clause and phrase thereof would have been adopted, irrespective of the fact that one or
