Water-wise Landscape Program



PWD has received 42 WWLCP applications so far, with 32 completed YTD. A total of 49,113 sq ft has been converted and \$75,124.50 in cash has been awarded.



36842 Burroughs Way - 1,587 sq.ft. converted. Before project, water bill average was \$111.23 (22 CCF) Project finished May 2023. Water bill amount was \$80.67 (17 CCF) June-September 2023 average (6 CCF). Bill after conversion \$58.19, saving an average of 16 CCF.



1724 High Vista Ave - 1,425 sq.ft. converted. Before project water bill average was \$125.81 (28 CCF) Project finished January 2023 - Water bill amount was \$82.37. February-September 2023 average (11 CCF). Bill amount after conversion \$56.99, saving 17 CCF.



6019 Lisbon Ct - 1,000 sq.ft. converted. Before project water bill average was \$98.82 (22 CCF). Project finished June 2023 - Water bill amount was \$77.28 (18 CCF). July-September 2023 average bill amount after conversion is \$62.24 (10 CCF), savings of 12 CCF.



37627 49th St. E. - 747 sq.ft. converted. Before project water bill average was \$51.94 (6 CCF). Project finished March 2023 - Water bill amount was \$49.79 (3 CCF). April-September 2023 average bill amount after conversion \$47.66 (2 CCF), saving 4 CCF.



36902 32nd St. East - 1,641 sq.ft. converted. Before project water bill amount average was \$90.38 (18 CCF). Project finished July 2023 - Water bill amount was \$73.16 (15 CCF). August-September 2023 average bill after conversion \$52.48 (6 CCF), saving 12 CCF.
