# Water-wise Landscape Program



PWD received 60 WWLCP applications in 2023 of which 43 projects were completed. A total of 54,593 sq ft was converted and \$84,507 in cash awarded.





5327 Sunburst - 1,457 sq.ft. converted.

Before project water bill amount average was \$153.16 (34 CCF).

Project finished March 2023 - Water bill amount was \$72.63 (15 CCF).

April-December 2023 average bill after conversion \$64.80 (11 CCF), saving 23 CCF.





38252 Mentor Ct - 1,501 sq.ft. converted.

Before project water bill amount average was \$70.07 (13 CCF).

Project finished July 2023 - Water bill amount was \$64.05 (11 CCF).

August-September 2023 average bill after conversion \$58.67 (4 CCF), saving 9 CCF.





5767 Monaco Dr - 1,592 sq.ft. converted.

Before project water bill amount average was \$90.38 (18 CCF).
