# MINUTES OF REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT, JULY 8, 2024:

A regular meeting of the Board of Directors of the Palmdale Water District was held Monday, July 8, 2024, at 2029 East Avenue Q, Palmdale, California, in the Board Room of the District Office. President, Kathy Mac Laren-Gomez, called the meeting to order at 6:00 p.m.

#### 1) Pledge of Allegiance/Moment of Silence.

President Mac Laren-Gomez led the Pledge of Allegiance followed by a moment of silence in honor of fallen Los Angeles County firefighter Andrew Pontious.

#### 3) Adoption of Agenda.

# 5.1) Water Quality Regulatory Overview. (Operations Manager Marcinko/Water Quality and Regulatory Affairs Supervisor Thompson)

Operations Manager Marcinko provided a detailed presentation on water quality including the Environmental Protection Agency and State of California Division of Drinking Water Regulations, the water quality categories, the monitoring schedules, the content and frequency of reporting, and proactive planning for future regulation changes.

Water Quality and Regulatory Affairs Supervisor Thompson then provided a detailed overview of the Leslie O. Carter Water Treatment Plant Laboratory including the staff and their respective roles, the sample collection locations and testing, and the laboratory certification requirements and Field of Accreditations followed by a brief discussion of the sampling and reporting processes, of the interties with Littlerock Creek Irrigation District (LCID) and Antelope Valley East Kern Water Agency (AVEK), of water quality monitoring of private wells, of distribution system designs, and of the District's flushing program.

Operations Manager Marcinko then stated that he is thoroughly impressed with the water quality, staffing, and operations of the District and he is proud to be part of this organization followed by further discussion of emergency events and response efforts and of the annual Consumer Confidence Report.

#### 8.2) Report of General Manager.

General Manager LaMoreaux stated that staff was proactive in planning for the extreme temperatures and holiday last week; that on July 4, there was a large water

main leak at 3<sup>rd</sup> Street East and Palmdale Blvd. resulting in loss of water to In and Out and that staff made repairs as quickly as possible; and that there has been a series of break-ins and stolen copper parts at District sites and that reports have been filed with the Palmdale Sheriff's Station followed by discussion of water theft and security measures.

#### 8.3) **Report of General Counsel.**

Assistant General Counsel Vargas provided a brief legal update on the California Supreme Court's ruling to reverse the Public Utilities Commission's order from 2020 on water surcharges for failure to properly notify water utilities on the elimination of the surcharge mechanism.

After a brief discussion, it was determined that a discussion item be added to the next meeting agenda regarding the agenda for the next Antelope Valley Watermaster Meeting.
